



## 103rd Annual Celebration of Commerce & Community Awards

### Award Criteria:

1) **Business Person of the Year** *Criteria:* A business owner who exemplifies the total package; success in business, community involvement, leadership and integrity

2) **Small Business of the Year**

*Criteria:* A business (less than 15 employees) that is creating an impact through leadership and successful achievements in their chosen field and community initiatives that others strive to replicate

3) **Medium Business of the Year**

*Criteria:* A business (between 15 and 50 employees) that is creating an impact through leadership and successful achievements in their chosen field and community initiatives that others strive to replicate

4) **Large Business of the Year**

*Criteria:* A business (more than 50 employees) that is creating an impact through leadership and successful achievements in their chosen field and community initiatives that others strive to replicate

5) **Ambassador of the Year** *Criteria:* An Ambassador who is a highly visible, prestigious volunteer who serves as the Chamber's primary liaison

6) **Impact Award (Non-Profit)** *Criteria:* The non-profit who has made a significant impact on our community

7) **Volunteer of the Year**

*Criteria:* A person who has displayed selfless dedication of their time and efforts in contributing to the Chamber and its programs

8) **Public Institution of the Year (organizations such as a school, college, library, or hospital that is run for the public good)**

*Criteria:* A public firm that is creating an impact through leadership and successful achievements in their chosen field and community initiatives that others strive to replicate

**Nominating Criteria:** Nominees may only win one award. Nominees must be members in good standing of the Greater Kokomo Chamber of Commerce, a division of the Greater Kokomo Economic Development Alliance. Members may be nominated for any award, if applicable, but will not be eligible to win the same award in consecutive years.

**Selection Criteria:**

Three finalists and a winner will be chosen by the membership via survey. The winner will not be announced or made public until the Annual Celebration.

Finalists will be invited to attend the dinner on November 2, 2017 and each finalist will receive two complimentary tickets to attend.

**Deadline for nominations to be returned is Monday, October 9, 2017.**
